#### JOB PURPOSE & SPECIFIC RESPONSIBILITIES:

The Aircraft Load Control Agent is responsible for ensuring the safe and efficient loading of cargo, baggage, and passengers onto aircraft. They play a crucial role in maintaining the aircraft's balance and weight distribution, ensuring compliance with safety regulations and optimizing fuel efficiency. This position requires attention to detail, excellent communication skills, and the ability to work in a fast-paced environment.

#### Specific Responsibilities:

- Preparing and reviewing load plans for each flight, considering weight restrictions, balance, and aircraft performance requirements.
- Collaborating with ground handling personnel, airline staff, and flight crew to ensure accurate and timely loading operations.
- Verifying and documenting the weight and balance of all cargo, baggage, and passengers using approved weighing equipment and software.
